# Sunrise Beach

As we look ahead, the Sunrise Beach property market is poised for an interesting ride, shaped by various economic and political factors. With an imminent state election and a federal election expected by May 2025, uncertainty is likely to impact buyer sentiment and market dynamics.

Median house price now sits at \$1,817,500 a modest increase over the past 12 months. Units have reduced slightly in value to a median of \$840,000. There were 56 houses and 40 units sold in the past 12 months. Average days on market for houses and units are 65 and 67 respectively.

The upcoming state election is expected to result in a change of government, which could bring new policies and priorities that influence the housing market. Additionally, the potential for a minority federal government may lead to further political volatility. This environment of increased tension, especially with ongoing political issues in the Middle East, could create hesitation among buyers and investors.

Despite the political uncertainties, there is cautious optimism regarding inflation. The ongoing issues with sticky inflation could see a resolution in the near future, paving the way for the Reserve Bank of Australia to consider a series of interest rate reductions in the first half of 2025. Such moves could significantly boost buyer confidence, encouraging more activity in the market.

The combination of these factors suggests that buyers will be making considered decisions, closely monitoring economic indicators and political developments.



However, if inflation stabilizes and interest rates decline, we could see a resurgence of buyer interest and a more dynamic market environment.
